Envió esta carta con el fin de que ustedes me solucionen el problema que tengo. Como ustedes saben que yo jairo charris castro tengo orden de captura por parte de la fiscalía general de la nación. Doctor Jiménez para su conocimiento la empresa Multinacional drummond fue la que mando hacer el trabajo de los 3 sindicalistas. El señor jin jakin hablo conmigo en la oficina de servicios especiales para coordinar la operación en contra de los 3 sindicalistas ya que los señores mencionados eran los que coordinaban las voladuras de los trenes con la guerrilla de las FARC. También hice un curso de manejo defensivo en la mina y el personal de servicios especiales me saco de la mina por orden del coronel luís Carlos Rodríguez. Doctor Jiménez

Cordial Greetings

I am sending you this letter for you to solve this problem I am having. As you well know, I, Jairo Charris Castro, have an arrest warrant against me from the Attorney General of the Nation. Doctor Jiménez, for your information, the multinational Drummond was the one that ordered the job on the 3 union leaders. Mr. Jin Jakin [sic] spoke with me in the office of special services to coordinate the operation against the 3 union leaders since those men were the ones who coordinated the blasting of the trains with the FARC guerrillas. Mr. Jin Jakin told me to get those people out of the way, because they were causing considerable damage to the company Drummond. That was when I coordinated the operation that took place. That you were the beneficiaries, and that doctor Jaime Blanco's contract was taken from him has nothing to do with this problem since Mr. Jin Jakin assured me that the contract would not be taken from him and that it could be renewed for 4 more years, with the company Industrial de Servicios de Alimentos ISA but all that was a lie, they offered me money for the operation that was carried out and it was just a promise by Drummond. I also took a defensive driving course at the mine and the special services personnel got me out of the mine by order of Colonel Luis Carlos Rodriguez. Doctor Augusto Jiménez, I want you to have clear in your mind that Mr. Jaime Blanco did not agree with that job and since I was the head of security of Industrial de Servicios y Alimentos I had all the autonomy and coordination with the special services security part, directly with Colonel Luis Carlos Rodriguez, who later barred me from the mine, never to be allowed back in. Doctor Jiménez, when the operation was about to be done, I asked Mr. Jin Jakin who was authorizing that job and he told me it was authorized by Mr. Gary Drummond, Augusto Jiménez, Alfredo Araujo, General Peña Ríos and Colonel Luis Carlos Rodríguez, and he told me he was Gary Drummond's and Augusto Jiménez's right hand man. Doctor, you know that with the death of Mr. Hugo Guerra, Mr. Jin Jakin gave me a check to pay the Commander alias El Tigre for that job, and that money came from Colonel Garzón, the Chief of Security the Drummond rail line. Doctor Jiménez, the union is offering me money to tell the truth to the magazine "Semana" and they are sending me through Venezuela to the United States for me to tell the truth to the international human rights office but I don't trust those people. I have never liked the union. The Prosecution has told my family that I should turn myself in, that I should seek benefits and protection. Doctor Jiménez, I am a witness to all the coordinations between the company Drummond and the AUC.

Doctor Jiménez, the only person giving me a hand, economically, was Mr. Jaime Blanco, but now he is not doing well economically himself. I am not doing well economically - I have to pay for an attorney and I have no money, my wife and children are not faring well economically, doctor Jiménez. Please don't take this as a bribe - it's just reality. Regarding the facts, my family knows that if you make any attempt on my life, that you are responsible, as the company Drummond.
